The facility will be open at 7:00 AM each day.

Entries: Each team may enter a maximum of four (4) participants per individual event (this includes diving) and one (1) relay team per relay event. All Divers will compete in an 11 dive format for the meet. All participants are limited to a maximum of two (2) individual events and two (2) relays or one (1) individual event and three (3) relays. Diving counts as (1) individual event.

All entries including relays must be submitted using an entry time that has been achieved during the current high school season. Names of relay swimmers (minimum of 4 names and a maximum of 8 names) must be included with the relay entry. **No Time (NT) entries will NOT be accepted.**

Only the fastest 32 female and 32 male athletes will be seeded into the 500 Freestyle events plus two alternates. Coaches of swimmers that are dropped from the 500 due to entry limitations will be allowed to add the dropped swimmer into another event, provided that team entry limits are not exceeded – no more than 4 swimmers per individual event per team. Coaches must notify Melissa at mbripley56@msn.com by 12 Noon Saturday, October 16th of the desired change for the dropped swimmer.

Girl's events will compete first odd event numbers and Boys will follow in the even event numbers.

Scoring will be as follows:

Individual events – 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1

Relays – 40, 34, 32, 30, 28, 26, 24, 22, 18, 14, 12, 10, 8, 6, 4, 2

Awards: 1st through 4th Place Medals for all Individual and Relay events. Plaques will be awarded to the top three Girl's Teams and the top three Boy's Teams.

Entry Fees: Team entry fees will be \$400.00 per school or \$150.00 for ONLY Dive Teams entering.

All Swimming entries MUST be submitted electronically using Team Manager or Team Manager Lite and e-mailed to Melissa Ripley at mbripley56@msn.com by the entry deadline. Paper entries for swimming will not be accepted. Eleven Dive Diving Sheets should be e-mailed to Melissa Ripley at mbripley56@msn.com. Please make sure you include a contact name and phone number on all communication in case there are questions about your entry. A Team Manager event file will be made available for teams to enter their team electronically. **Please make sure your divers are also entered on your electronic entry to ensure their results get uploaded to Max Preps.**

Rules:

1. All divers must be checked in with their sheets signed *before* beginning warm-up. Paper copies of each entry will be provided to make changes and sign at check-in.
2. Sheets may not be changed after check-in signature.
3. Each team is required to provide one judge for the meet – this can be a coach. The individual may be asked to be on a judging panel or assist with table work.
4. We would like all divers to have the opportunity to dive all 11 dives but if the timeline determines the meet is too long diving cuts will be made as follows: All entrants will dive the first 5 rounds (prelims), then the field will be cut to 24 divers for rounds #6-8 (semi-finals), then another cut to 16 divers for rounds #9-11 (finals).
5. Girls and boys will be diving together – a girl's round followed by a boy's round

Registration:

1. Download the EZ Meet "High School Dive Sheet Verifier" from <http://www.diverline.com/DiveVerifierInfo.html>
2. Use EZ Meet's Dive Verifier Excel spreadsheet template to create 11-dive sheets for up to 4 girls and 4 boys. The macros contained in this template will verify whether the dive sheets are legal, and if not, advise on how to correct them. Please do not submit unverified entries.
3. Create a separate document for each dive sheet (provide a unique file name for each diver). Information can be entered and saved as often as desired just as with any Excel document.
